- Mr. Compton spoke on the county employees' insurance. He stated if premiums went up \$100 that we would have classified personnel having to choose between paying insurance premiums and feeding their families. He stated the School Board and everyone needs to "step up" and let people know we will pay our 62% if they increase it if the general county pays the other part for the sheriff or Mr. Dunlap. He stated he thinks it is time for the county to" step up" and pay the extra part of the money and let it go through collaborative conferencing and talk about it.
- Mrs. Sudhoff stated she was very excited about the school year and the enthusiasm she has seen in the students and their families. She thanked Mr. Farmer for all of the improvements they had made.
